



2010 Craft/Retail Vendor Application

The undersigned applies to Sevier County to sell goods on the Sevier County Fairgrounds, at 410 East 200 South, Richfield, Utah during the Sevier County Fair, August 11, 12, 13, & 14, 2010.

- * A regular booth space fee is \$80 for all four days. A booth with Electricity is \$100 for all four days. An additional security fee of \$50 is required.
- * Booth space is limited at the fairgrounds. Booth space will be at a first come, first serve basis.
- * Booth space will be a 10' x 10' space. Vendors will provide their own shade tent, tables, chairs, counters, display boards, tarp, etc.
- * Booths set up on the grass MUST stake tents or covers in the grass. Booths set up on the pavement/black top MUST anchor tents down with sand bags or equivalent.
- * No duplication of booths will be permitted. Booth space will be approved at a first come, first serve basis.
- * Electricity will be available upon request, please specify below, limited spaces available.
- * All booths need to be in operation during the County Fair. Booths need to be set up each day by 12:00 noon and stay open until 8:00 p.m..
- * Vendors are responsible for removing trash and debris from their booth space.
- * Sevier County will not be liable for property loss or personal injury to anyone participating in any way in the Sevier County Fair.
- * Applicant agrees to ALL Vendor Booth Rules and Guidelines.
- * \$50 security fee will be returned when all guidelines are followed.
- * Non-Profit/Educational booths (upon approval of Fair Committee) are not required to pay the \$50 booth fee, but will be required to pay the \$50 security fee.

Booth Guidelines/Rules

Please carefully read the following:

BOOTH RESTRICTIONS: Space is limited at the Sevier County Fairgrounds, so acceptance of booths will end when capacity is reached.

TAXES: Any and all sales taxes incurred as a result of sales during the Sevier County Fair are the responsibility of the individual vendor. Applicants are responsible for the collection and payment of all sales taxes as well as all other taxes and assessments attributable to the applicant's activities. Per state statute, each vendor will be assigned a temporary tax ID number from the state of Utah and information on all vendors will be submitted to the State Tax Commission.

ELECTRICITY: Electricity will be provided upon request of the vendor. Spaces are limited.

EQUIPMENT: The Sevier County Fair will not provide canopies, tables, chairs, or other equipment for vendors. Please plan to bring with you any and all items you need to set up and care for your booth. Booths set up on grass MUST stake tents/canopies down in the grass. Booths set up on the pavement/blacktop area MUST anchor tents down with sandbags or items equivalent. NO STAKES ARE ALLOWED on pavement/blacktop. Please be advised we have had strong winds in the past. It is highly recommended you deep anchor your tents/canopies.

SECURITY: The applicant understands that there will be no security provided for any booths or equipment at the Fairgrounds. Booths and valuables will be left at the park overnight at the applicant's own risk.

FOOD/BEVERAGES: The sale of any and all food and beverages are limited, with rights allowed only to organization(s) selected by the Sevier County Fair Board. No Exhibitor will cook or sell any food items.

QUALITY PROVISION: The Vendor will maintain and uphold a family-oriented theme while renting, displaying, and selling products during the Sevier County Fair. If the Sevier County Fair Board deems sales inappropriate, undesirable, or lacking in quality, they reserve the right to terminate the sale of any item or prevent any activity at any time.

OVERNIGHT PARKING/CAMPING: Unless specific permission is granted by the Sevier County Fair Board overnight camping or parking is not allowed on the Fairgrounds. All vehicles must be removed to the Fairground parking lot during open Fair Times each day.

THE SEVIER COUNTY FAIR BOARD RETAINS THE RIGHT to terminate any application or regain possession of booth space at any time.

WAIVER: Applicants agree to indemnify and hold harmless Sevier County, the Sevier County Fair Board, volunteers, and sponsors from any claims, suits, losses or other actions arising from injuries or accidents attributable to applicants' activities whether or not such injury or accident involves applicants', employees, agents, guests, invitee's, or a member of the general public. Vendors are fully responsible for their own items and any damage that may occur from the weather.

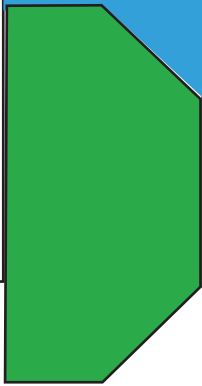

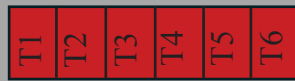

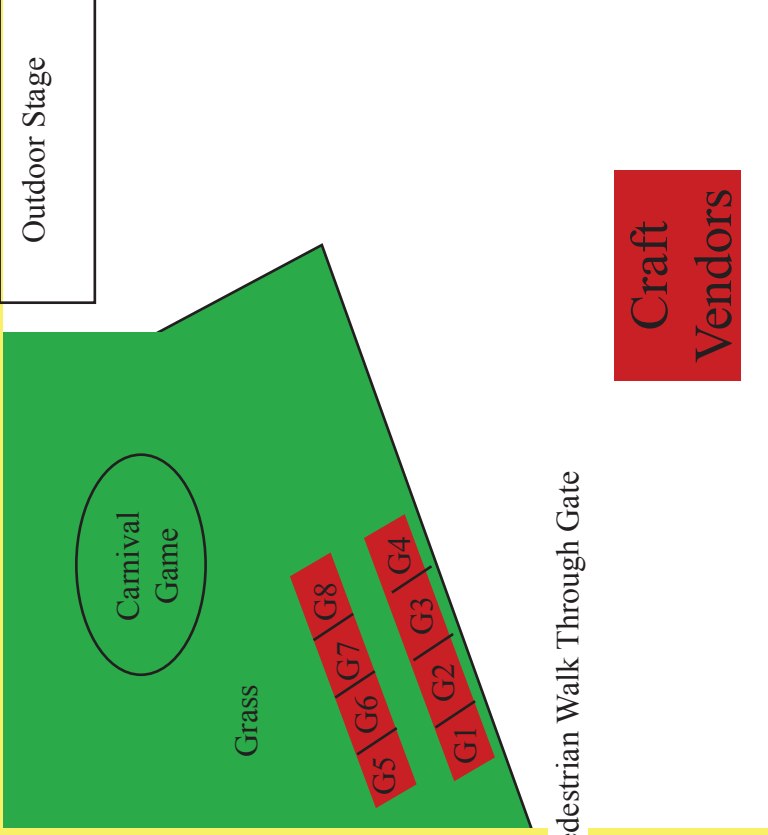
